**\*\* New 2021 update for the 50th Anniversary Parade:** The Farm City Days Committee is hoping to make this year's 50th Anniversary Parade the biggest parade ever! Our goal is to have over 100 entries for the parade. AND this year we are allowing semi-trucks and trailers to enter! \*\*

**Check In (9:00am)** - You will check-in at the corner of Jefferson and Lincoln. There you will receive the number that corresponds with your description entry. Please place this number on your passenger side window so it can be read clearly by announcers.

**Line Up/Route** - You will not line up in numerical order. You will check in and be told where to go. The parade route will begin at the normal starting point at Jefferson and Monroe St., travel South on Jefferson St. until turning west on Madison St., until reaching Walnut St. and turning north down Walnut which will then end on Monroe St.

**Please Note:** Absolutely NO throwing candy or other items from your float, vehicle or by anyone walking. Also, we reserve the right to refuse entry to any person, group, or entity.
